3 Introduction

Greater Noida, a progressive urban hub, recognizes the multifaceted significance of street vending in urban dynamics. Beyond being a source of employment, street vending infuses cities with vitality and allure, while also serving as an informal mechanism for surveillance. However, the absence of dedicated spaces for vendors, coupled with unplanned urban expansion, has led to unregulated proliferation along roads and vital intersections. This, in turn, has resulted in chaotic traffic conditions, challenges in crowd control, and waste management complexities.

In a notable departure from the prevailing trend, Greater Noida has proactively addressed these challenges by introducing sector-wise vending zones, equipped with cutting-edge amenities, catering to eligible vendors. A remarkable stride has been made, with the development of four out of twelve vending zones, showcasing our commitment to organized urban growth.

In continuation of this transformative journey, the Greater Noida Industrial Development Authority (GNIDA) seeks to engage with prospective and capable bidders interested in undertaking the operation and maintenance of these four vending zones. Through this Expression of Interest (EOI), we invite qualified entities to partner with us in realizing the full potential of these spaces, fostering harmonious coexistence between vendors, patrons, and the urban environment.

4 Scope of Services

- a) Operational Excellence:
 - Oversee the smooth functioning and day-to-day management of the entire premises.
 - Adhere to Service Level Agreements (SLAs) outlined in Annexure B of the Request for Proposal (RFP).
- b) Zone Management:
 - Efficiently manage designated street vending zones in alignment with GNIDA's regulations and guidelines.
 - Ensure proper utilization of allocated spaces, preventing encroachments and unauthorized activities.
 - Ensure vendors occupy their designated spaces.
- c) Infrastructure Maintenance:
 - Regularly inspect and maintain infrastructure including stalls, kiosks, seating, waste disposal facilities, and utilities.
 - Address day-to-day wear and tear to keep the facilities in good working condition.
 - Perform premises painting every 12 months as specified, with penalties for non-compliance.
- d) Hygiene and Sanitation:
 - Implement robust cleaning and waste management programs to maintain clean, hygienic, and aesthetically pleasing vending zones.
 - Employ proper waste segregation and disposal methods to minimize environmental impact.
- e) Security and Safety:
 - Ensure safety and security of vendors and visitors within the vending zones.
 - Prevent theft, vandalism, and other security issues.
 - Develop contingency plans for emergencies to ensure safety.

- f) Traffic and Crowd Management:
 - Develop strategies to manage pedestrian and vehicular traffic around the vending zones.
 - Prevent vending activities from obstructing traffic flow or posing safety hazards.
- g) Compliance and Enforcement:
 - Monitor and enforce adherence to all applicable rules, regulations, and permits related to street vending.
 - Take appropriate actions against violations and non-compliance.
- h) Reporting and Documentation:
 - Maintain comprehensive records of activities, incidents, and changes within the vending zones.
 - Prepare regular reports for relevant authorities to track progress and compliance.




Figure 1. Locations of 04 vending zones




Figure 2: Alpha 2 vending zone






Figure 5: Beta 2
