1. Is it true that in case of acquisition from pre-1991 owners of land in Village Bisrak Jalalpur, GNOIDA Authority is required to provide additional compensation in forms of residential plots in Greater Noida to the extent of 6% of their acquired land?
2. Was Rina Sarin 1/3 owner of land situated in Gata 824 Rakba 5-9-0 Khata no.35 in Village Bisrak Jalalpur w.e.f. 18-07-1989?
3. Was part of her land acquired consequent to GNOIDA advertisement dated 03.06.2001 in "Amar Jwala" and she was paid a compensation of Rs.393617.00?
4. Was the rest of her land subsequently acquired and she accepted Rs.2598960.00 in April 2010, under protest?
5. As per rules is she entitled to additional compensation?
6. Did Rina Sarin write to Chief Executive Officer GNOIDA on 07.10.2011 asking for additional compensation as per rules?
7. Please convey decision on her letter dated 07.10.2011.
8. Has, in addition to monetary compensation, any plot been allotted to any person whose land was acquired by GNOIDA Authority in Bisrak Jalalpur?
9. Has any plot, residential or otherwise, been allotted to Rina Sarin as additional compensation after her land was acquired in Bisrak Jalalpur?
10. If not, reasons for not allotting a plot to Rina Sarin after acquiring her land in Bisrak Jalalpur.
